Description and purpose of the change

An Olin Radio policy was created to ensure a consistent work process is followed across the TXO site. This work process will follow the guidelines currently in place lined out in the Olin/Dow site service agreements and Motorola requirements.

Implementation of this policy will ensure the following expectations are met and maintained:

- ~ Facility accountability and documentation logs of all Olin owned radios.
- ~ Roles and Responsibilities for all Olin employees and contractors regarding radio use.
- ~ Facility Focal Points of contact regarding requests for radio repairs, programing, replacement and purchase.
- ~ A documented work process outlining the approvals necessary from Site Security, Dow and Olin Contract Management when additional radios are being requested.
- ~ Ensuring contractual radio inventory limits are maintained on the Dow radio system.
- ~ Ensuring unnecessary costs are not incurred.
- ~ Building a site inventory database of all Olin owned radios to include spare radios that will be utilized in times of need.
- ~ Reviewing, creating and partnering with Motorola in a service contract agreement that will create a cost savings.

Implementation tasks and actions to follow this MOC:

- Implement facility radio management utilizing template outlined in MOC
- Submit a facility master radio log to Site Security Focal Point
- Review and update Facility Security Plans as needed
- Communicate expectations to all Olin employees at TXO

Technical basis for the change

The Basis for this Policy is to clarify requirements and work processes. This will align with expectations outlined in Dow/Olin site service agreements.

Clarifying the process and expectations will restrict unnecessary spending on site radios. This will also enforce all the necessary reviews to ensure contractual inventory limits are not being exceeded on the Dow radio system.

Implementing management systems will ensure traceability and accountability for all radio communication assets for our site and facilities
